## Dear Supporters and Friends,

Dear Supporters and Friends,

Last year, I had the opportunity (and I was old enough) to retire. I had worked as an RN for over 35 years and healthcare was in the process of another big change with lots of new regulations. I thought I was ready to sit back. I was retired about a month, wandering around the house and trying to decide if I wanted to wash windows, clean closets, or take a nap, when my husband suggested I look for another job. I was so grateful for the suggestion.

I am part of the roughly 75 million Americans who make up the baby boom generation. Approximately 3 million baby boomers will hit retirement age every year for about the next 20 years, and it will affect how caregivers and policymakers shape the health care system for decades to come. Boomers will be leaving the workforce in growing numbers, creating voids in clinical care and health care management.

By 2029, when the last boomers reach retirement age, the number of Americans age 65 or older will climb to more than 71 million. A huge proportion will switch from commercial insurance plans to Medicare. Research has found that despite a longer life expectancy, boomers have higher rates of hypertension, high cholesterol, diabetes, and obesity. We are more ethnically and racially diverse, more educated, and we want to be more involved with health care decision-making. Active boomers will want to keep their mobility, will rely more on complementary medicine, and will be more familiar with and demanding of palliative care.

Caregivers are also aging, along with our physicians, nurses, personal care aides, and even family members. We are going to need about 1.6 million new health care professionals. We do not have a younger generation in sufficient numbers to replace those caregivers that will be needed. Alternative models of care are being explored along with new advances in technology.

With the changes in the country and community demographics, we need to be preparing for this wave of boomers—too many patients and not enough caregivers. Hospices across the country are looking at ways to expand their programs and services while recruiting a younger generation of caregivers. Hospice of the Foothills has an advantage that others may not. We have the Compassionate Care Home, a 12-bed hospice inpatient facility that can help meet the needs of our aging boomers at the end of their lives.

We observed the 5th anniversary of the opening of our Compassionate Care Home this past August. Our hospice program and hospice home can provide support to boomers with their decisions on how they will spend the end of their lives. It is one of the most important decisions they will make.

Hospice is about choices, quality of life, and involvement of the patient and the family in those very important conversations.

# Dedicated Duo Retires from Hospice of the Foothills Board

*Still Passionate About Compassionate Care for Patients and Families*



**T**wo of Hospice of the Foothills' most dedicated volunteers were honored on their retirement at a recent gathering of Hospice's Boards of Directors. Barbara J. Belmer and Charles (Chuck) Zavitz served on the Board of Directors for a combined 23 years. Barbara and Chuck's dedication to Hospice of the Foothills goes far beyond the board room. The pair have much in common in addition to their commitment to Hospice. Both were raised on the east coast and attended colleges there. Both eventually found their way to Nevada County, bringing unique skills and life experiences that, for more than 20 years, have helped Hospice grow, expand, and enhance its programs and facilities.

Following military service in Korea, Chuck made his way across the country; first to Denver, and eventually San Francisco where his entrepreneurial spirit flourished. He founded a number of start-up companies in the Bay Area and worked as a financial consultant to small businesses. In 1988, Chuck bought a small accounting firm in Grass Valley, site unseen, after his wife Betty spotted a "for sale" ad while they were having breakfast at a Millbrae Pancake House. Chuck calls the move to Nevada County "serendipity." Shortly after the move, Chuck, a CPA, began keeping the Hospice books. Chuck served for 14 years as Board Treasurer. His financial expertise and guidance were essential to Hospice of the Foothills' transition from a small group of volunteers in the mid-eighties, to the professional health care organization it is today.

Following her move to Grass Valley, Barbara attended the Friends of Hospice annual Breakfast in the Park fundraiser. She soon became an enthusiastic Friends' volunteer, and served as President of the event auxiliary for two years. She was also a member of the Board of Directors for nine years. Prior to relocating to our community in 1996, Barbara was already passionate about the precepts of hospice care having met Dame Cicely Saunders, the founder of the modern hospice movement, in the mid-sixties. She was an administrator at the Memorial Sloan Kettering Cancer Center and, later, at St. Luke's Hospital, both in New York City. There she learned the skills of fund raising and relationship-building - skills she has used to guide strategic fund development planning for Hospice as Chair of the Fund Development Committee.

Barbara and Chuck were among the first recipients of Hospice of the Foothills' Dame Cicely Saunders Awards, held during the annual meeting of the Circle of Care members in the spring of 2014—an honor well-deserved. Both are passionate about the hospice mission. Their long-time, ongoing generosity demonstrates their shared dedication to Hospice of the Foothills and the compassionate care provided to patients and families. Both have been Caring Sustainers in the Circle of Care since its inception in 2010.

# A Compassionate Home Away from Home

Last year, Hospice of the Foothills provided end-of-life care to more than 500 patients and families in our community. Hospice of the Foothills provides care wherever the patient is: hospital, skilled nursing facility, assisted living facility, and home. Most patients prefer to be cared for in their own homes. But for some, staying at home is not possible.

There can be a number of obstacles to in-home care for some patients. Among them are caregivers who are exhausted and in need of a few days of respite. There are those patients at home whose symptoms suddenly spiral out of control with pain, nausea and vomiting, terminal agitation, or seizure activity. These patients do not want to go back to the hospital, yet their symptoms cannot be managed at home. That is why Hospice of the Foothills' Compassionate Care Home was built and is the optimal setting for these patients.

The Compassionate Care Home opened its doors in August, 2010, offering a quality of care at levels not previously available in Nevada County. In the five years since, our dedicated interdisciplinary care team has cared for 588 patients and provided support for their families and loved ones. Many of our patients present with complex medical conditions requiring the round-the-clock, comprehensive care provided in the Home.

Some of our patients arrive so late in their disease cycle that they are unable to receive the full benefits of hospice care. Others, like a young mother with three small children, was recently admitted to the Compassionate Care Home. After being cared for at home, her symptoms required more intense intervention than could be provided. Admission to the Compassionate Care Home allowed her complex medical needs to be met while her husband and children had the reassurance of a safe, home-like setting, which included a children's corner with books, dolls, and toys.

This case is not an exception, but an example of Hospice of the Foothills' commitment to the community to provide the highest quality of hospice care and services to patients with a life-limiting illness and their families. It is an example of the provision of care and services regardless of the patient's financial circumstances.




